OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE A PARTICIPANT'S CHANCES OF WINNING.

CONTEST DESCRIPTION:

The Athlete of the Mic contest ("Contest") will begin on April 19, 2024 and end on June 7, 2024 ("Contest Period"). This Contest will be conducted online and on-site. There will be a total of four (4) finalists from the Online and On-site Contest (one (1) from on-line submissions; one (1) from each on-site audition). The four (4) finalists will perform live at Hot 107.9 Who's Hot Competition in Atlanta. One (1) grand prize winner will be selected from among the finalists. The grand prize winner will be awarded a performance spot on the main stage at the Hot 107.9 Birthday Bash at State Farm Arena. All four (4) finalists will receive two (2) premium tickets to Birthday Bash. Roundtrip airfare to Atlanta, GA and hotel accommodations in Atlanta will be awarded to out-of-state winners (Total ARV \$2,500). Hot 107.9 Who's Hot Competition is on Friday, June 21 and Birthday Bash takes place on Saturday, June 22, 2024 in Atlanta.

HOW TO ENTER / EXECUTION:

Listeners of WHTA-FM ("Station") who are legal residents of the United States and are 18 years of age or older will be able to take part in this Contest. There are two methods of Contest entry. To participate in the Contest, participants must use one of the following methods:

Online Entry

- Participants must submit a video of up to a maximum of two (2) minutes showcasing their solo or group rap performance using original material. Any video over two (2) minutes will be disqualified. Performances must be clean with no explicit language, gestures, or drug references. If any of these are used, the contestant will be disqualified.
- Contestants must submit their entries through the contest website at www.theathleteofthe

 mic.com. There will be a link on the Station's website (https://hotspotatl.com/) that will guide listeners to the Contest registration site.
- Upon entering the website, participants are to follow the on-screen instructions, including entering their name, date of birth, address, phone number, email address, and any optional or additional contact information, as requested, to register for a chance to win.
- Submitted entries must be "family friendly", appropriate for all audiences, and must meet the below-listed Entry Requirements.
- All Internet entries must be received by 11:59pm EST on June 7, 2024, or they will be void.
- One entry per person or group during the Contest Period.

- In the event of a dispute regarding the identity of a participant's online entry, the entry will be deemed to have been made by the authorized holder of the e-mail account at the time the entry was made.
- By uploading a submission and entering this Contest, each participant represents and warrants to be bound by these Official Contest rules, and that they are authorized to and have the rights to submit the content within the entry.

On-Site Entry

 For Dallas, the cut-off date to purchase and receive a guaranteed audition is May 15th. All guaranteed auditioners must check-in the day of the on-site auditions by 2pm. Failure to check-in by 2pm will forfeit your guaranteed spot.

- Each contestant will be required to sign and submit a Participant Release Form prior to their live performance.
- Participants' performances will be reviewed and critiqued by a panel of judges comprised
 of Station personnel and record company representatives. At the sole discretion of the
 judging panel, one (1) finalist will be selected at each live audition location and will be
 determined on same day of the live performance. (go to www.theathleteofthemic.com for

- There will be a total of three (3) finalists determined from the live auditions. The three (3) finalists (one (1) finalist from each location) will perform at Hot 107.9 Who's Hot Competition.
